PROCLAMATION SAMPLE WORDING – 100TH BIRTHDAY

WHEREAS, Clarence William Smith was born approximately 24 miles southwest of Saginaw, in St. Charles, Michigan on September 12th 1907; and

WHEREAS, he can trace his ancestry in Saginaw County to William Harrison Smith who was a member of the 16th Michigan Regiment during the Civil War and is buried in Homer, Michigan; and

WHEREAS, he graduated from local St. Charles High School at the age of 17 and then from the University of Michigan, College of Engineering in 1930; and

WHEREAS, he then married Skowhegan, Maine native Elsie Madeline Montgomery in 1932 and had three children with eight grandchildren and four great-grandchildren following; and

WHEREAS, he was civil engineer first in the Honduras before World War II and in Puerto Rico, during the war. As an engineer with the US Geological Survey he and his survey crews mapped much of the eastern United States including parts of northern Michigan that had not previously been mapped. His son, as part of a survey crew in Antarctica, placed a brass marker on an unnamed mountain, naming it in his honor; and

WHEREAS, he still enjoys walking at St. Charles High School when the weather is good and tending to his small vegetable garden at his residence in St. Charles; and

WHEREAS, the arc of his life spans 100 years and the majority of his life has been experienced in St. Charles and Saginaw County Michigan he is worthy of having a day named in his honor as a small token of appreciation for his contributions to this community;
