St. Charles Village Council Minutes of Regular Meeting April 8, 2020

Meeting called to order at 7:00 PM with the Pledge of Allegiance by President Hoerner.

Lois Theile joined the meeting via telephone audio at 7:08 PM on Aue's cell phone.

Aue informed Council that the bids for the Fulton/Hosmer water main project came in March 24th. Five bids were received, with the lowest coming in at \$526,853.18. He spoke with John Olson from Spicer asking about prices and the size and scope of the project. Aue believes that it is in the best interested of the Village to move forward with the bid from Eric Construction on the water main portion of the project, do the job the right way, with new meter pits, road crossings and connections, which will set the Village up for success on the future water main connections in the coming years, with having to dig twice in the same area within a two-year span. The quote for the water main project only was \$278,756.

Motion by Neumann, second by Kutz to accept the bid from Eric Construction for the Fulton and Hosmer water main project not to exceed the amount of \$278,756. Roll call vote: L. Theile- yes; Kutz-yes; Neumann- yes; Hoerner- yes; McPhail- yes; Dennis- yes; S. Theile-yes. Motion carried.
