#### **Rules & Regulations:**

- > Spaces will be filled in order of application along with full payment.
- ➤ All merchandise is subject to review by organizers. Unsuitable items must be removed immediately upon request.
- ➤ Booth areas must be attended at all times to ensure the safety and care of vendor items.
- ➤ Vendors are required to provide any tents, tables and chairs needed to display their products and operate their booths.
- The area around the booth must be barrier free.
- ➤ After unloading vendors must remove their vehicles and park in the specified vendor parking area.
- ➤ Vendors must furnish their own cleaning and sanitizing materials and are responsible for all garbage removal at the end of the day.
- ➤ Alcoholic beverages are prohibited.
- > Vendors are responsible for their own cashbox.
- ➤ All vendors are responsible for state sales tax and must display a tax ID if applicable.
- ➤ The sale of food or beverage products must abide by the Michigan Cottage Food Laws and in full compliance with local health department regulations. Any licenses, permits or fees necessary must be obtained by the vendor.

#### **Insurance:**

The Village of St. Charles and the event coordinators **DO NOT** carry any insurance policies nor do they convey the protection through any policy to vendors selling at this event. The Village of St. Charles and event coordinators will not be held responsible for any claims or for the safety of products sold at the market.

The Village of St. Charles and event coordinators reserve the right to amend, add to or delete any rules and regulations as necessary to carry out the operation of the event.
